1. The United Republic of Tanzania has received financing from the World Bank towards the cost of the Zanzibar Energy Sector Transformation and Access Project. Zanzibar Electricity Corporation (ZECO), and the implementing agency intends to apply part of the proceeds toward payments under the Contracts for "Power Distribution Network Refurbishment and Strengthening and Last Mile Connections in Unguja Island, Zanzibar".
2. ZECO now invites sealed Bids from eligible Bidders for Procurement of Plant Design, Supply, and Installation (on turnkey basis) of the above-mentioned Contract title, the brief scope and qualifications' requirement of the same are as mentioned in the table below:

Bidding will be conducted through international competitive procurement using Request for Bids (RFB) [Single Stage, Two Envelopes Bidding Process using Rated - Criteria] as specified in The World Bank's Procurement Regulations for IPF Borrowers, Fifth Edition, September 2023 [Procurement in Investment Project Financing for "Goods, Works, Non-Consulting Services and iS Consulting Services"], and is open to all eligible Bidders as defined in the Procurement Regulations.

All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Employer until the second public Bid opening.
