Tanzania Communication and Development Center (TCDC) is a local NGO, empowering Tanzanian households and communities through Social and Behavior Change (SBC) and SMART Advocacy geared towards social development.

TCDC works with the government of the United Republic of Tanzania on Social and Behavior Change and Advocacy strategies in the areas of health, social, and economic issues to improve the lives of Tanzanian communities. Currently, TCDC Implements Social and Behavior Change (SBC) and Advocacy interventions on Malaria, comprehensive HIV care and treatment, Water, Sanitation and Hygiene (WASH), Nutrition, Family Planning (FP) and Tuberculosis (TB), Reproductive, Maternal, Newborn, child and adolescence health (RMNCAH).

- ii. Company certificate of incorporation/Registration,
- iii. Memorandum and Articles of Association,
- iv. VAT Registration Certificate (VRN) and TIN Certificate
- v. Registration from relevant professional boards for Companies and Experts (if any),
- vi. Proof/Certificate of manufacturer dealership/Agent with reputable goods/service (if any,
- vii. Current physical location (which will be inspected for verification); that is a valid right of occupancy of office premises or lease contract,
- viii. Power of Attorney
- ix. TRA Tax compliance (Tax clearance certificate for year 2023-2024,
- x. Current annual return updated in the BRELA online registration system/ORS detailed company search report
 - 2. Experience: A minimum of three (3) years in business with a proven track
 - 3. **Client's** reference: (At least three clients including business verification which are contracts or LPO)
 - 4. Audited Financial statements for two years of 2022 and 2023
 - 5. Portfolio: Evidence of completed Health projects or campaign with NGOs or similar industry or sector

The Selection Criteria for LOT NO: TCDC/PS-25-25 (This LOT will not be mixed with other categories in evaluation) will include additional to general criteria's above:

- 6. **Financial Stability:** Evidence of financial statements (audited) for the past 3 years, bank statement and the company must have a capital of TZS 100 million.
- 7. Documented proof of at least three (3) similar projects over 3 recent years (2022-2024)
- 8. Reference from previous clients or testimonials at least three clients in similar ore related industry.
- 9. Proof of ownership or access to necessary equipment's relevant to field operations. Attach documents of ownership

Please note that in evaluating the submissions, consideration will be given to companies that comply with submission requirements, Eligibility Criteria's, Technical capacity, Financial Capacity, Reputations and references. Only eligible and qualified Companies will be considered.

Deadline for submission of the documents is Wednesday 5th February 2025 at 12:00HRS/Noon. Applications will be opened promptly thereafter in public and in the presence of bidder's representatives who will choose to attend the meeting.

Applicants must include one original and a copy of their tender document. The documents must be properly filled and enclosed in plain envelopes clearly marked "Pre-qualification for Provision/Supply of (put the name of the selected service/goods) - Not to be opened before Wednesday 5th February 2025 at 12:00HRS" hand-delivered or courier to CDC through addresses provided below.

Late applications, portion of applications, and electronic applications not received, opened and read out in public at the tender opening ceremony shall not be considered for evaluation irrespective of circumstances.

Only eligible and qualified Companies and Experts with demonstrated experience and excellent track records ir similar assignments will be considered. Potential supplier may be requested to submit further information prior to being included in any final list.
