The Government of the United Republic of Tanzania has received a loan from the Japan International Cooperation Agency (JICA) towards the cost of Arusha - Holili Road Improvement Project and intends to apply part of the proceeds of this loan towards payments under the contract for Package 1: Widening of the Tengeru-Usa and Moshi Town sections of Arusha-Holili Road resulting from the bidding for which this prequalification is conducted.
2. The Tanzania National Roads Agency now intends to prequalify firms for the widening of 11.6 km of Tengeru-Usa section and 11.5 km of Moshi town section of the Arusha-Holili Road from two (2) lanes to four (4) lanes including construction of small to medium sized bridges as well as construction of a weigh station at Mabungo. It is expected that Invitation for Bids will be made in December 2024.
3. Prequalification will be conducted in accordance with the specified Guidelines for Procurement under Japanese ODA Loans and IS open to all Applicants (single firms or Joint Venture) from eligible source countries as defined in this Prequalification Document.
