2. This EOI S the start of an open, transparent, and objective tender process which will commence from the date of this notice.
3. Bidder must be an experienced and capable environmental consulting firm to undertake the following Scope of Work
 - (i) Conducting a comprehensive environmental and social audit in accordance with Regulation 50(1) of the Environmental Impact Assessment and Audit Regulations, G.N. No. 349 of 2005.
 - (ii) Enhancing and integrating the existing ESMPs and ESMoPs to align with current operations both upstream and downstream resulting in two comprehensive plans: one dedicated to Songo Songo Island operations and the other for the downstream natural gas distribution network in Dares Salaam.
4. Requirements
 - (i) The consulting firm must have at least five (5) years of working experience in conducting environmental and social audits in the oil and gas industry.
 - (ii) Key personnel required but not limited to Team leader, Registered environmental consultants, Sociologist, Botanist and Marine Biodiversity Specialists and all must be registered and approved by NEMC and any other accredited regulatory body.
 - (iii) Technical and managerial capability of the firm to provide consultancy services related to environmental and social audits. Bidding consulting firms to provide CVs of key personnel/experts and organization structure.
